AFFIDAVIT OF LOREN ESTLEMAN

Loren Estleman, being duly sworn on his oath, states as follows:

- 1. I have personal knowledge of the facts contained in this affidavit and as described below.
 - 2. I am a writer and recognized authority on genre fiction and character development.
- 3. Since my first novel was published in 1976, I have published nearly seventy novels and nonfiction books in several literary genres.
- 4. I developed my principal detective character, hard-boiled Detroit private eye Amos Walker, through twenty-four novels and short story collections since 1980, with a new Amos Walker novel due out shortly.
- 5. My second series detective character is a Los Angeles "film detective" for UCLA called Valentino, with four novels and short story collections about him to date.

- 6. In a different genre, I have written a seven-novel Western series about a lawman acting for a federal court, along with eighteen other stand-alone Western novels to date, winning half a dozen national book awards for the historical accuracy of my depiction of the American West.
- 7. In 2004 I authored *Writing the Popular Novel*, and have also contributed essays about the craft of detective fiction to *Writing Mystery and Crime Fiction* (ed. Sylvia Burack, 2012), *Writing the Private Eye Novel* (Private Eye Writers of America, 1997), and *Writing Mysteries* (Mystery Writers of America, 2002).
- 8. I have detailed and personal knowledge of the Sherlock Holmes character. My two novels, *Sherlock Holmes vs. Dracula* and *Dr. Jekyll and Mr. Holmes*, originally published in 1978 and 1979 respectively, are still in print today. Last year I published *The Perils of Sherlock Holmes*, a collection of his short stories, and a new collection also edited and authored by me, *Sons of Moriarty and More Stories of Sherlock Holmes*, will be published this November.
- 9. I am the author of the standard *Complete Sherlock Holmes* paperback edition in America, published by Bantam Books (a Random House division), a work in print (including ebook) since 1986. *The Perils of Sherlock Holmes* contains two nonfiction essays ("Channeling Holmes" and "On the Significance of Boswells") about Conan Doyle's Sherlock Holmes and Dr. Watson characters in new fiction by others.
- 10. For my fiction and nonfiction I have won many literary awards and additional nominations, including an Honorary Doctorate in Letters, and have been the Guest of Honor at a number of literary conventions devoted to the detective and Western fiction genres.
- 11. I created the characters Amos Walker, Page Murdock, Peter Macklin, and Valentino in 40 books over 34 years. I did not create or fully develop these characters in the first novel in

traits, likes, dislikes, and identities as I write new novels about each of the characters.
